2:17 (Dash cam) Indian Shores Officer and PCSO Deputies conduct a Felony traffic stop at 177th Ave W and Gulf Blvd. (Car is facing south at 1:37 a.m.)

2:26 ISPD Officer Martin: "Front driver's side tire is completely flat it's about to flail off in here a couple of seconds. Pulling up to a stop at 177th Avenue West. 177th Avenue West and Gulf Blvd."

2:45 Dep: "Get out of the car! Get out of the car! Hands up!"

2:45 Dep: "Driver! Turn the car off! Put your hands out the driver window."

3:09 Dep: "Driver, turn the vehicle off."

3:13 Dep: "Driver put your hands up and put your hands outside the vehicle."

3:18 (different body cam view 1:49 a.m.)

3:20 Dep: (on loudspeaker) "Marina.... (Russian orders) "

3:25 Dep: "Oh there's a gun, she's pointing it out. Yep"

3:26 Dep: "(Unintelligible)...squad car"

3:42 Dep: "Marina... (Russian orders) Drop the gun."

3:53 Dep: "From the- from the north to the south. They can- they can pop out over there."

4:12 Dep: on radio, "Alright, I believe she put the gun down, I don't see it in her right hand that last time but let me- let me, uh, confirm If I, uh, see it in her right hand again."

4:18 Dep: Oh, she's- she's going again. She's moving, she's moving."

4:28 Deputies: "Hey guys" "Hey get back." "U-Turn" "Making a U-Turn guys" "Hey buddy, get out of that B-Pillar."

4:38 Dep: "If she takes- off we're going to let her leave."

4:39 Dep: "Yep."

(1:51 a.m.- Suspect vehicle leaves the felony traffic stop and slow roles U-Turn, driving back northbound)

4:57 ISPD Officer: "Somebody got stop sticks to put up down here before she turns? Oops too late."

5:35 MRAP executes PIT maneuver and the Toyota is spun around and is now facing south. 2:03 a.m.

5:50 Toyota drives off towards Dep. Reidy
hear 1st round of gunshots

5:56 Same minute but from Dep. Reidy's bodycam 2:03 a.m. standing behind his open car door

6:00 Dep: "Stop! Stop!"

6:06 Toyota smashes into the open door where Dep. Reidy was standing. He is injured.

6:14 ([Different Dash Cam](#)) Toyota is pinched between patrol cars. Squeezes through

Dep: "She's still got the gun."

Gunshots

6:20 Dep: "Ceasefire. Ceasefire. Shots fired"

6:33 "Firearm right hand. Firearm right hand!" *Shots* "Get back!" Toyota squeezes through and drives thru and drives towards a patrol car.

6:40 ([Dash cam perspective](#)) Toyota squeezes thru as Deputies fire until it crashes head-on into patrol car. 2:04 a.m.

6:41 Dep: "Get down!" *Shots*
